Reservations

Party Size For the safety of all our guests the maximum number of occupants allowed is 8. When making reservations, provide the total number of adults and children in your group. You must be a minimum of 25 years of age in order to rent property from rentfollybeach.com. Persons under 25 years of age must be accompanied by an adult, parent or guardian during their stay. Valid identification will be requested upon check-in. Any reservation obtained under false pretense will be subject to forfeiture of payments and not be allowed to check-in or possibly be asked to vacate the premises.

Rental Rates/Seasons During the Summer season our property is rented Saturday-to-Saturday. Partial weeks may be booked during the Summer season no earlier than 7 days prior to the requested arrival date and are based solely upon availability. Partial week reservations are accepted during the Fall, Winter and Spring seasons with a three night minimum.

Taxes & Fees Each reservation is subject to a 14.5% State Sales taxes. A \$59 Property Damage Protection fee is due upon reservation as well as a \$150 cleaning and linen fee.

Damages Any damages, outside of what is deemed normal wear and tear, are the responsibility of the guest. A credit card is required to guarantee against damage or excessive cleaning. Should the guest not report damages prior to their departure or should rentfollybeach.com deem the damage to be intentional, the guest's credit card will be charged for the repair, replacement and or/cleaning.

Payments A deposit of ½ (one-half) the total is due to make the reservation. We accept Visa, MasterCard and Discover credit/debit cards and PayPal. Payment confirmation can be e-mailed, or faxed. The account balance, including sales tax, security deposit, cleaning and linen fee and the other half of the rent is due 30 (thirty) days PRIOR to the check-in date.

Cancellations Notice of cancellation must be in writing. Your advance payment is refundable if the cancellation is received 60 days or more prior to your arrival date. There is a \$100 cancellation fee.

Cancellations made inside 60 days lose their first payment unless the property is considered a cancellation and the same terms apply. Refunds are not given for inclement weather, road or airport closings, late arrivals, or early departures.

Catastrophic Events & Emergency Evacuations: If a catastrophe (hurricane, tornado, earthquake, flood, etc.) or any situation simply beyond our control impairs the vacation rental, Rent Folly Beach, LLC is not responsible for finding alternate lodging for the renter or for the renter's financial losses related to transportation or alternate lodging. There will be No Refunds or Credits for Emergency Evacuations / Weather Conditions. Therefore, we suggest you consider Travel Protection Insurance to secure your vacation investment and eliminate your financial risk.

Smoking No smoking is allowed inside the unit. Evidence of smoking inside the unit will incur a fine of \$200 and immediate termination of occupancy without a refund.

Pets Our property does not allow pets. Evidence of pets will result in a \$200 fine and immediate termination of occupancy without a refund.

Grilling (barbequing) Our property does not allow Grilling inside the units or on the patios/walkways. Evidence of grilling will result in a \$250 fine and immediate termination of occupancy without a refund.

Linens Linen service is included in your cleaning and linen fee. All beds will be made and 1 bath towel, 1 hand towel, and 1 wash cloth per person will be provided. 2 kitchen towels will also be supplied for the property.

Furnishings Our property is equipped with basic items such as TV, spreads, pillows, mattress pads, cookware, flatware, microwave, toaster and coffee maker. Specialty items vary.

GRILLING ON DECKS OR PORCHES IS PROHIBITED!

Housekeeping Guests are required to remove all food products from the pantry, fridge and freezer. We also ask that you wash dishes or start the dishwasher, take the trash to the bin and move all furniture back to its original place.

Phones Local calls and emergency dialing are permitted from the property, free long distance service is provided for calls within the United States and Canada.

Housekeeping Equipment All equipment should be in working order. PLEASE NOTIFY US PROMPTLY SHOULD YOU ENCOUNTER ANY PROBLEMS. We make every effort to have repairs made as soon as possible.

We strongly encourage you not to adjust the settings on the refrigerator and be sure not to run the HVAC system with the windows open. A reduction in rent or a refund will not be issued for any mechanical failures of appliances or HVAC systems. Every precaution has been taken to assure accuracy of a properties description and/or contents; however, we reserve the right to make necessary changes.
